Community Council News for June 2023

Details of some of the items discussed at the Meeting held on 20th June 2023 at Is-γ-coed Village Hall.

TO ELECT A CHAIR OF THE COUNCIL AND RECEIVE THE CHAIR'S DECLARATION OF OFFICE:

Councillor Ellis proposed that Councillor P Jones continue in the role of Chair of the Community Council, and this was seconded by Councillor Edwards. There were no other nominations put forward, and the proposal was upheld and agreed by those Councillors present. Councillor P Jones was duly re elected to the role of Chair of the Community Council.

TO ELECT A VICE - CHAIR OF THE COUNCIL: Councillor Jones proposed Councillor P Ellis to the role of Vice-Chair, seconded by Councillor S Ellis, and the proposal was upheld and agreed by those Councillors present. Councillor P Ellis was duly re-elected to the role Of Vice-Chair of the Community Council.

ATTENDANCE AT THE MEETING OF MR HARRINGTON, TO ADVISE COUNCILLORS OF THE NEW ROUTE FOR THE UPCOMING CHARITY RUN, AND TO DISCUSS ONGOING CONCERNS: Mr Harrington advised that he had met with Wrexham Council Highways department as previously agreed, to present a new route, and this had been accepted by Wrexham Council as a safer alternative. The route is one-way, access is maintained throughout and there is no need for road closures. All aspects of the revised route were discussed, including the start and finish points and times, the length and timing of the route, and marshalling and traffic management. Questions were put to Mr Harrington. After consideration, the revisions were accepted by the Community Council as being more acceptable and having addressed many of the concerns previously raised. It was agreed that the Village Hall entrance and car park could be used at the end of the run to filter runners through safely back across the field to the starting point. The date of the run is 23rd July. Mr Harrington was thanked for attending and left the meeting.

ATTENDANCE AT MEETING OF MRS D PRIDDING, RESIDENT, TO DISCUSS ISSUES RELATING TO OLD FARM, AND THE ACTIONS TO DATE BY THE COMMUNITY COUNCIL: Mrs Pridding sent apologies as she was unable to attend the meeting. The Clerk advised on responses received on this matter from Wrexham Council Planning and Environmental Health departments. These had been passed to Mrs Pridding. A discussion took place about the use of farm buildings and Councillor Morris advised on the Planning position. It was confirmed that videos and notification of the issue regarding traffic had been passed to North Wales Police. Concerns were still ongoing about the speed of vehicles. After discussion it was agreed that a further letter should be sent to the Planning department, highlighting the time this is talking to reach Committee, and to resolution, and a letter to Highways department. Councillor Morris advised he was due to accompany the PCSO in the near future and would discuss the traffic concerns with her.

MATTERS ARISING FROM MINUTES: Councillor Jones advised that the school is celebrating its 150 years anniversary and are looking at a Victorian theme. The Community Council is invited to take part. A Welsh flag has been purchased to fly on the flagpole.

VILLAGE HALL: Councillor Edwards advised the meeting concerning grants, and a report he had received about the heat loss/energy efficiency survey. It was confirmed that the Wrexham Council officer was due to visit to discuss the application for the Community Benefit grant. A further blocked gully on the main road had been unblocked by WCBC which should alleviate the flow of water away from the car park. It was agreed that another Community Day should be held at the hall to do some further clearing work and this shall be 22nd July

FLAGS PURCHASED TO MARK THE CORONATION OF KING CHARLES: Councillor Jones confirmed his purchase of the poles and flags, and it was agreed to reimburse him for the amount of £145.97. It was suggested that the Council purchase a 'Lest we forget' flag for Remembrance week, and Councillor Jones will also ask the Church if they can suggest anything that can be commemorated with a flag,

TO CONSIDER ANY PLANNING APPLICATION UNDER REQUESTS AND COUNTRY PLANNING ACT 1990

P/2023/0280- Hybrid planning permission (a) outline permission (all matters reserved) except for means of access for erection of up to 3 warehouse and distribution units (use class B8) and (b) Full planning permission for demolition, means of access, earthworks, drainage, landscaping, ecology zone and relative ecological mitigation measures and ancillary works:-Land off Bryn Lane, Wrexham Ind Estate. This was discussed generally as being a large development near to Isycoed and of some concern. The Planning Officer had agreed an extension for comments until after the July meeting. It was resolved that the Clerk will circulate the documents via e-mail, allowing proper viewing and an appropriate response will be discussed at the July meeting.

MEMBERS REPORTS:

Councillor Worsnop raised an issue of grass cutting of verges down the lanes which is affecting visibility and safety. The Clerk will write to WCBC.

Run Cheshire Events in Bowling Bank and Is-y-coed. (Case Ref. SA12707)

Some residents have contacted Sarah Atherton, local MP, to express their concerns regarding the Run Cheshire events. Sarah has got in touch with Wrexham Council to highlight these. This in turn has been referred to a council run Safety Advisory Group (SAG) who are made up of various authorities: -Police, Fire, Highway's etc. This group have already had a pre run meeting with Michael Harrington, the organiser of Run Cheshire and are planning a further post run meeting with him. Feedback will be sourced from all authorities, and it has been suggested that residents also have their input, providing constructive feedback-whether that is negative or positive. Questions being asked are:-

a) List what you thought was successful or observed working well in the whole event-for example-site layout, site safety, crowd control, welfare facilities, infrastructure, power supply, transport. communication.

b) List or describe what you thought was NOT successful or did not work well in the whole event, also considering the examples above.

All feedback will be collated and discussed at the SAG meeting.
